

**WAIVER IDEMNIFICATION AND LIABILITY RELEASE AND ENTRY FORM**

I the undersigned, understand that in exchange for, and as a condition to, my participating in the activities of the Man About Town Poker Run, I am herewith releasing Soroptmist and the Land Owners and Managers (Hereafter the PROMOTER), its officials, directors, servants and employees the cities, counties, state and municipalities (hereafter "CITIES): the sponsors, co-sponsors, contingency sponsors and officials of the event, for all responsibility to me, my heirs, executors and assigns for anything that occurs during the event. It is my intention that this release is extended to my use of any and all related facilities, including, but not limited to my use f the course and related facilities.

I ALSO UNDERSTAND THAT OFF ROAD DRIVING IS A DANGEROUS ACTIVITY. I ALSO KNOW THAT IN PARTICIPATING IN **THE MAN ABOUT TOWN POKER RUN**, I AM EXPOSING MYSELF TO THE POSSIBILITY OF SERIOUS INJURY AND DEATH TO MY PERSON AND MY PROPERTY. I VOLUNTARILY ACCEPT THOSE RISKS.

I do hereby for myself, my heirs, executors and assigns, AGREE with Soroptmist and the Landowners and Managers as follows:

1:I RELEASE Soroptmist and the Landowners, Managers, their Officials, Agents, Assignees, Servants and Employees, the events PRODUCER, SPONSORS, CO SPONSORS, CONTINFENCY SPONSORS and related personnel FOR ANY AND EVERY CLAIM OF RIGHT OF ACTION OF ANY KIND OF NATURE WHICH ARISES OUT OF OR RESULTS FROM MY PARTICIPATION IN THE "EVENT" AND MY USE OF ANY AND ALL RELATED FACILITIES. INCLUDING, BUT NOT LIMITED TO, THE USE OF THE COURSE AND SUCH RELATED FACILITIES. I also agree to indemnity and hold harmless Soroptmist, the Land Owners and Managers, and their Officials, Directors, Servants and Employees from all such claims or rights of action, as well as any cost, loss or expense, including attorney fees, in any related to or arising out of those claims or right of action.

2.I intend that the release, indemnity and hold harmless described in Paragraph "1", shall cover any claim or demand for injury to or death of any person or any damage or any destruction of my property, including but not limited to injury to me or my property. My release indemnity and hold harmless SPECIFICALLY INCLUDING INJURY, DAMAGE AND DESTRUCTION TO PERSON, PERSONS OR PROPERTY WHICH MAY ARISE OUT OF OR BE CLAMED TO ARISE OUT OF NEGELGENT ACTS/OR OMISSIONS OF THE "PROMOTER AND THE CITIES" AND THEIR OFFICIALS, DIECTORS, SERVANTS AND EMPLOYEES, THE PRODUCERS SPONSORS, CO-SPONSORS AND CONTINFENCY SPONSORS OF THE MAN ABOUT TOWN POKER RUN.

I do not by singing this Waiver, Indemnification and Release, release anyone from any damages I suffer from the intentional acts designed to harm, either me or my property. I DO RELEASE THE PROMOTER, AND THE CITIES AND THEIR OFFICIERS, DIECTORS, SERVANTS AND EMPLOYEERS, and the EVENT PRODUCER, SPONSORS, CO SPONSORS AND THE EVEN PRODUCER, SPOINSORS, from liability that might be imposed on them by law for such acts of others that they have nor directed, adopted or ratified.

I have read the foregoing Waiver, Indemnifications and Release, and fully understand that no officer, employee or other agent of the PROMOTOER and the CITIES AND THEIR OFFICIERS, DIRECTORS, SERVANTS AND EMPLOYEES, and the EVENT PRODUCER, SPONSORS CO-SPONSORS AND CONTINGENCY SPONSORS, is or authorized to vary any item or provision of this instrument or to make any representation contrary to the above and should not rely on any such variance or representation.

I DECLARE THAT I POSSESS THE STANDARD OF COMPENTENCE NECESSARY AMD AM PYSICALLY FIT TO PARTICIPATE IN ANY EVENT OF THIS TYPE for which this entry relates and that the vehicle entered is OFF ROAD WORTHY.

I hereby certify that I have read this form, and that I understand its entire contents. I also certify that I agree and shall comply with all rules and regulations set forth for this event. I shall not allow anyone, other than the undersigned entrant(s) to participate in the event or to drive the vehicle, which I (we) the undersigned, have entered.

In the event that the weather or other ACTS of GOD occur the course may be re-routed or changed. There is always the chance these conditions could also cause the official's of this event to postpone the event.
